

Nor-Gwyn Pool Rules and Regulations

The rules below are designed to promote a welcoming and safe environment for all patrons and guests.

1. Be respectful of our facility and courteous to everyone. Please obey the lifeguards and management staff.
2. Your membership ID card is required for admittance each time you enter/re-enter the pool grounds.
3. Members' guests must register at the front booth and wear a wristband for the day. Sponsoring members must accompany their guests while at the pool.
4. Children under 12 must be accompanied – and monitored – by a responsible caretaker over 16.
5. NO GLASS CONTAINERS are permitted inside the facility at any time. Management reserves the right to inspect coolers and bags entering the facility. Food and drinks are permitted. Please dispose of all waste in appropriate receptacles.
6. No alcoholic beverages, smoking or vaping on Township property or within the facility. Anyone suspected of being under the influence of alcohol or drugs will be evaluated by the Upper Gwynedd Police and subject to removal, and suspension or loss of membership.
7. Please WALK while on paved surfaces. Horseplay in the pool, on the WIBITs, or on the decks is not permitted.
8. Shade umbrellas may only be opened/closed by staff members. Do not hang or attach anything to umbrella.
9. Parents of children in a swim class or team practice must stay outside the fence or under the baby pool pavilion. Do not distract the instructors during class. Speak to the teachers/coaches before or after class ONLY.
10. Only management-approved flotation devices are permitted. Children using flotation devices must stay in the pool's shallow end, may not use the slides/WIBITs and must be accompanied by a parent when in the water.
11. No fins, mermaid tails, or other such devices are permitted.
12. Persons who have had a contagious illness (e.g.: pink eye or stomach/intestinal virus) within a 24-hour period are not permitted in the pool.
13. Swim diapers are required for infants and toddlers who are not yet toilet trained.
14. Pets are not permitted on the premises except for select events.
15. Young children must pass a deep-water swim test to use the slides, diving boards or WIBITs. After passing this test, deep-water wristbands must be worn. Lost wristbands may be replaced for a fee. Deep-water privileges/wristbands may be revoked if the child requires guard assistance or is unable to use the equipment on his/her own.
16. Jumps or dives off the diving board must be straight forward (not to the side), one bounce is permitted. One person on the diving board at a time, wait until the person in front of you exits the pool before diving, exit the pool at the ladder closest to the diving board, do not touch the fulcrum (rotating wheel) on the board.
17. Proper swim attire is required when in the pools (no street clothes). Those who cannot wear traditional swim suits are required to wear swim attire made of synthetic, swim-suit material (lycra, nylon, etc.)
18. Ball throwing is limited to the grassy areas away from other patrons. No hard balls may be used at any time.
19. Any behavior endangering yourself or others or disturbing other patrons is not permitted.

WIBIT rules are posted on the bulletin board.

In the event of any combination of the following, the aquatic facility reserves the right to limit the number of guest passes or close the facility: low/high attendance, bad weather, staffing availability and private events.

By entering the facility, you are agreeing to these Rules and Regulations – as interpreted by the pool management. The staff reserves the right to enforce additional rules or prohibit any activity not mentioned above to ensure the safety, comfort and security of all.

ANYONE VIOLATING THESE RULES MAY BE ASKED TO LEAVE THE FACILITY AND MAY LOSE THEIR MEMBERSHIP.
